- Continual access to the thesis by the author and others, any time and any place (24/7/365)
- Provides a convenient, single online location to which future researchers can refer.
- Increases the likelihood that the work will be discovered by others in diverse locations, thus increasing the ease of access to and visibility of students and their work, potentially enhancing job prospects or graduate school placement for students.
- Shows the global community CCU's commitment to undergraduate research.
